Under the general direction of the Parks & Facilities Superintendent, responsible for general maintenance of grounds areas and facilities.

Primary Duties & Responsibilities

- 1. Clean and make minor repairs to pavilion areas and site amenities.
- 2. Sweeps, rakes, picks up litter, and empties trashcans.
- 3. Plants flowers, shrubs, and trees.
- 4. Maintains plant material by watering, pulling weeds, applying fertilizer, herbicides, and woodchip.
- 5. Uses hand tools such as garden hoses, shovels, brooms, rakes, hoes, trimmers, saws, and clippers.
